**Date, Time, Setup & Tear Down:** Saturday, Oct. 7, 2017. Doors open to the public at 10:00 AM and close at 5:00 PM. The Fair closes Saturday at 5:00 PM. Booths must be dismantled prior to 6:30 PM. You may be responsible for a \$50 fee if you fail to be out of the facility by 7:00 PM.

**Registration:** The enclosed Application form (with Release & Indemnity Agreement) must be read, completed, signed and returned to Universal Life & Light, along with your registration fee. All applications are subject to approval by Universal Life & Light. **Registration must be completed prior to setting up at the event.** This includes completed Application and Release & Indemnity Agreement, and payment in full. Once full application has been received, future fair bookings only require Release & Indemnity Agreement, along with table size and choices.

**Registration Fee:** Table Fees are listed on the Application. **In addition to table fees, there is an additional fee of 10% of sales/services to be paid at the end of the event. Make checks payable to Mystical Winds.** You may also pay with PayPal using [Universal.Life.Light@AwakeningUniversalGifts.com](mailto:Universal.Life.Light@AwakeningUniversalGifts.com), or by emailing to request a Square Invoice. If payment arrangements are made and not honored, no space will be reserved for future events without payment being received in full. No transfers or refunds of table fees.

**Booth Set-Up:** You may begin setting up your space two hours prior to the doors opening. Please note, the first hour the room may still be being setup. If you chose a space with access to electricity, and verified electricity was available for your table, **please come prepared with extension cord for up to 24 ft to make sure you have it at your table.** Bring your own extension cord and Painters tape to keep the cord in place and prevent anyone from tripping over the cord. Please ensure your floor area is cleaned up at the end of the event. You will be responsible to any damage to chairs, tables and floor area in your space. Please notify Universal Life & Light immediately of any damage to your space. **Nothing may be put on the walls without receiving approval.**

**Safety:** To ensure a safe (fire regulations) and healthy (allergies, etc.) for everyone, burning of incense, candles, or other related items, is prohibited. No Exceptions, we appreciate your full cooperation.

**General Information:** You are expected to remain in your space throughout the day, except for reasonable breaks. We use door prizes, given by you, to gift the general public attending the event, and our vendors names will also be added to the drawings. Be prepared to donate a door prize the day of the event, and make sure to include your contact information with the Door Prize.
